Criminal Complaint

Todd Tollefson, Court Officer, being first duly sworn, states that:

Count 1: USE OF A COMPUTER TO FACILITATE A CHILD SEX CRIME

The above-named defendant between January 23 and February 23, 2009, in the City and County of Eau Claire, Wisconsin, did use a computerized communication system to communicate with an individual who the actor believed or had reason to believe had not attained the age of 16 years with intent to have sexual contact or sexual intercourse with the individual in violation of s. 948.02 (1) or (2), contrary to sec. 948.075(1r), 939.50(3)(c) Wis. Stats., a Class C Felony, and upon conviction may be fined not more than One Hundred Thousand Dollars (\$100,000), or imprisoned not more than forty (40) years, or both.

And furthermore, invoking the provisions of Wisconsin Statute Section 939.617, upon conviction the Court shall impose a bifurcated sentence including a term of initial confinement for at least five years. The Court may impose a sentence less than five years or place the person on probation upon a finding on the record that the Court finds the lesser sentence is in the best interests of the community and the public will not be harmed.

Count 2: ATTEMPT SEXUAL ASSAULT OF A CHILD UNDER 16 YEARS OF AGE

The above-named defendant on or about Monday, February 23, 2009, in the City and County of Eau Claire, Wisconsin, did attempt to have sexual intercourse with a child under the age of sixteen, contrary to sec. 948.02(2), 939.50(3)(c), 939.32 Wis. Stats., an attempt to commit a Class C Felony, and upon conviction may be fined not more than Fifty Thousand Dollars (\$50,000), or imprisoned not more than twenty (20) years, or both.

PROBABLE CAUSE:

The complainant is in possession of police reports by Fellow Officer Vandenberg, which form the basis for this complaint.

Special Agent Vandenberg states that on January 23, 2009 he had a on-line conversation with the user name WILLYBLACK2023. When asked, Agent Vandenberg told WILLYBLACK2023 he was female and 15 years of age. During the conversation, Special Agent Vandenberg states WILLYBLACK2023 had graphic and sexually explicit conversations with him. WILLYBLACK2023 told Vandenberg that WILLYBLACK2023 was 46 years of age 5'9" 170lb with blues eyes and salt and pepper hair. Special Agent Vandenberg states that WILLYBLACK2023 added Vandenberg to his Yahoo buddy list showing the name William Blake as the user's profile. Vandenberg states William Blake used file sharing and sent a photo of himself to Vandenberg along with photos of what William Blake reported was his cabin. Special Agent Vandenberg states that William Blake agreed to meet Vandenberg at a Kwik Trip in Eau Claire for the purpose of having sex on January 23. He said he would be driving an gray 88 Olds. Vandenberg states that William Blake failed to show.

On January 23, 2009 Special Agent Vern Vandenberg confirmed that William Blake lives at 1331 Bellevue Street #415 Green Bay WI according to a search on Accurint and records from the Wisconsin Department of Transportation, which located a William T Blake living at 1331 Bellevue Street #415 Green Bay, WI, with a DOB of 10/12/1962. Vandenberg states the photo he received from WILLYBLACK2023 and DL photo of William Blake are one and the same. Vandenberg states on January 23, 2009 he spoke with Special Agent Matthew Joy who informed Vandenberg that while conducting surveillance at William Blake's residence at 1331 Bellevue Street #415, Green Bay, WI he saw a vehicle in the driveway that fit the description Blake gave to Vandenberg.

Special Agent Vandenberg states that on January 28, 30, and February 12, 13, 17 and 19, 2009 he again had on-line conversations with William Blake. During those conversations, Special Agent Vandenberg states Blake had graphic and sexually explicit conversations with him. On February 12, Agent Vandenberg asked the defendant, "you really ok with me being 15?" The defendant replied, "yes if you like big cocks."

Special Agent Vandenberg states that on February 20th he communicated with William Blake who wanted to meet for the purpose of having sexual intercourse at a motel in Eau Claire on February 23rd 2009. Special Agent Vandenberg states that on February 23rd, Blake verified that he was leaving Green Bay at approx 9:30 a.m. and would meet Vandenberg at the Kwik Trip in Eau Claire at approx 1:45 to 2:00pm. Vandenberg states that Blake told Vandenberg, Blake would be bringing condoms, lube, and beer and would stop for food before going to a motel where they would have sexual intercourse.

Agent Vandenberg met the defendant as agreed in Eau Claire. He initially claimed he did not even have a computer. He had been in Minneapolis that morning. Agent Vandenberg said, "You're looking at Pam." The defendant's eyes got rather wide. He said, then I guess I am in trouble. The defendant admitted that he had come to Eau Claire to have sexual intercourse with "Pam" who he thought was a fifteen year old girl. When officers searched the defendant's car, they found condoms, personal lubricant and over the counter male sexual performance enhancement powder.

Based on the foregoing, the complainant believes this complaint to be true and correct.
