FACTS:

Your complainant is a Special Agent with the Wisconsin Department of Justice, Division of Criminal Investigation, and for this complaint is relying on the reports of Wisconsin Department of Justice Special Agents Jesse Crowe and Christopher Deremer.

SA Crowe reports that on June 1, 2011, he and other Special Agents served a search warrant at 6167 Dell Drive #2, in the City of Madison, Dane County, Wisconsin. In the basement of the residence, he contacted an individual identified verbally as Thomas R. Valley, the defendant herein, who advised that he lived at the residence.

SA Crowe reports that during the initial search of the residence, agents located multiple computers running along the north wall of the basement. SA Crowe reports that CFA Mark Howard removed hard drives from multiple computers belonging to and under the control of the defendant and recovered multiple contraband files from a hard drive in a blue Dell tower computer in the basement and multiple contraband files from an external hard drive attached to the blue Dell tower computer. CFA Howard copied the contraband files onto an optical disk and turned them over to SA Crowe, who reviewed them.

SA Crowe reports that he and SA Jennifer Price spoke with the defendant. The defendant stated that he has used Pirate Bay software to download torrents, but denied using Limewire. He eventually said that he had used Limewire in the past and had put in the search term "amateur". The defendant said that the Limewire folders on the external hard drive attached to the blue Dell were created in the fall of 2010. The defendant stated that when he used Limewire he would enter in "random shit" and "stuff just starting popping up". He stated that he would hit "control A" and then download (mass download all files). The defendant said, "I now realize that was the biggest mistake of my life". The defendant also stated that he would then take the files and edit them. He stated, "I started to edit some".
