### JUDGMENT

---

Based on the Stipulation between the plaintiff, State of Wisconsin and the defendants, Richard L. Ducklow, Richard L. Ducklow & Sons, Inc., and Richard L. Ducklow 2000 Revocable Trust (hereinafter collectively Ducklow), and on the Court's order, the terms of which are incorporated into this judgment in their entirety, judgment is

granted in favor of the plaintiff State of Wisconsin, and against the defendants in the amount of \$50,000.00. The \$50,000.00 is comprised of forfeitures, statutory surcharges, costs and attorney fees as follows: forfeitures of \$29,104.01 under Wis. Stat. § 281.98(1), a 26% penalty surcharge of \$7,567.04 under Wis. Stat. § 814.75(18), a 10% environmental surcharge of \$2,910.40 under Wis. Stat. § 814.75(12), \$25.00 in court costs under Wis. Stat. § 814.63(1), a \$13.00 crime laboratories and drug law enforcement surcharge under Wis. Stat. § 814.75(3), a \$68.00 court support services surcharge under Wis. Stat. § 814.75(2), a 1% jail surcharge of \$291.04 under Wis. Stat. § 814.75(14), a \$21.50 justice information system surcharge under Wis. Stat. § 814.75(15), \$5,000.00 for DNR's investigative costs, and \$5,000.00 for the Department of Justice's attorney fees pursuant to Wis. Stat. § 281.98(2).

Payments of \$13,333, \$13,333 and \$13,334 shall be made payable to the Monroe County Clerk of Circuit Court and delivered to the Clerk of Court at the Monroe County Courthouse, 112 S. Court Street, Sparta, Wisconsin, 54656, with a letter to the clerk identifying the case by name and number, on December 1, 2011, December 1, 2012, and December 1, 2013, respectively. A copy of each check and cover letter will be sent to Assistant Attorney General Diane L. Milligan, Department of Justice, Post Office Box 7857, Madison, Wisconsin 53707-7857. The \$5,000.00 payment to the Department of Justice shall be made payable to "State of Wisconsin Department of Justice" and shall be sent to Assistant Attorney General Diane L. Milligan, Department of Justice, Post Office Box 7857, Madison, Wisconsin 53707-7857 by December 1, 2011. The \$5,000.00 payment to DNR shall be made payable to the "State of Wisconsin Department of Natural

Resources," and sent to Assistant Attorney General Diane Milligan at the address noted herein by December 1, 2011.

If defendants fail to mail a check for the required amount on or before a payment date set forth in this stipulated judgment, then they shall be in default of this stipulated judgment. If they are in default, all financial obligations remaining under this stipulated judgment shall be accelerated and shall be immediately due and payable as set forth under this stipulated judgment.

This judgment is final for purposes of appeal.
