JUDGMENT

Based on the Stipulation between the plaintiff, State of Wisconsin and the defendants, Lee L. Cresca and Eagle Spring Environmental, Ltd., and on the Court's order, the terms of which are incorporated into this judgment in their entirety, judgment is granted in favor of the plaintiff State of Wisconsin, and against the defendants Lee L. Cresca and Eagle Spring Environmental, Ltd. in the amount of \$7,500.00. The \$7,500.00 is comprised of forfeitures, statutory surcharges, costs and attorney fees as follows: forfeitures of \$1,613.95 for the violations described in the complaint, plus \$419.63 for the

26% penalty surcharge under Wis. Stat. § 814.77(11), \$322.79 for the 20% environmental surcharge under Wis. Stat. § 814.77(5), the \$25.00 court costs under Wis. Stat. § 814.63(1), the \$13.00 crime laboratories and drug law enforcement surcharge required by Wis. Stat. § 814.77(2), the \$68.00 court support services surcharge as required by Wis. Stat. § 814.77(1m), \$16.13 for the 1% jail surcharge under Wis. Stat. § 814.77(7), and the \$21.50 justice information system surcharge required by Wis. Stat. § 814.77(8), plus \$3,000.00 for the costs of the Department of Natural Resources' investigation and \$2,000.00 as attorney fees for the Department of Justice under Wis. Stat. § 281.98(2).

Defendants will pay the judgment, along with outstanding judgments in Racine County Case No. 2005-CX-05 (\$4,000.00), Racine County Case No. 2005-CX-06 (\$23,647.50), Sheboygan County Case No. 2005-CX-05 (\$2,000.00), Washington County Case No. 2005-CX-08 (\$5,928.72) and Waukesha County Case No. 2005-FO-542 (\$2,850.00), in \$500 monthly payments as set forth in the Stipulation and Order

This judgment is final for purposes of appeal.
