COMPLAINING WITNESS

Jesse Crowe, et al.

The above-named complaining witness being first duly sworn states the following:

Count 1: SOLICITATION OF PROSTITUTES

The above-named defendant on or about Wednesday, March 13, 2013, Dane County, Wisconsin, did intentionally solicit a person to practice prostitution, contrary to sec. 944.32, 939.50(3)(h) Wis. Stats., a Class H Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than six (6) years, or both.

FACTS:

Your complainant is a special agent with the Wisconsin Department of Justice who is relying upon reports submitted by Inv. James Valley of the Door County Sheriff's Department who reports that on March 13, 2013, he was posting ads on Craigs List to solicit anyone interested in paying money for children for the purposes of sex. He posted an ad titled, "Lookin for a good time" and stated, "While there mommas away these girls will play. My girlfriend is out of town her daughters are ready to play with you. Be the first for these little people . . . \$ young \$\$ younger \$\$\$ youngest fifty \$ extra for an around the world experience." At around 2:42 in the afternoon Inv. Valley reports a subject replied, "Hey I'm game. Get back to me. Text me more info" and provided a number. Inv. Valley sent a female photo to which the individual responded, "Yummy she likes to play, yes so where and when, what kind of play are we talking about." Inv. Valley texted, "Dude what you want first and how much," to which the response was, "Good hot time you tell me how much," and they agreed upon a \$60 price for everything. They made arrangements to meet at 1114 O'Neill Ave., in the City of Madison, Dane County, Wisconsin.

03/18/2013

Special Agent Pertzborn arrived at that location at 4:47 p.m. and walked towards an individual and stated, "What's up man." Agent Pertzborn asked Crueger if he had a condom to which he replied that he did not and Agent Pertzborn asked Crueger if he had the \$60 to which Crueger stated, "Yah." Agent Pertzborn asked Crueger if he wanted to do it in the parking lot down the street to which Crueger replied by turning towards 1114 O'Neill Ave. and stating, "In my house." Agent Pertzborn asked Crueger if he had the \$60 to which Crueger stated that, "Yah, do I give it to her when she comes in then?" Agent Pertzborn stated, "Me," and put his hand out. Crueger then gave Agent Pertzborn three \$20 bills. A search of Crueger's vehicle was conducted and a passport was located which identified the individual as Douglas Crueger.

**THIS COMPLAINT IS BASED ON the information and belief of your complainant, who is a Special Agent for the Wisconsin Department of Justice, and who learned of the above offense from the reports of Inv. Valley of the Door County Sheriff's Department and Wisconsin Department of Justice Special Agent James Pertzborn, which report(s) your complainant believes to be truthful and reliable inasmuch as they were prepared during the course of the officer(s) official duties.

Your complainant believes the statements of the Defendant to be truthful and reliable insofar as they are admissions against penal interest.
